In pursuance of the decision of the High Power <sup>committee</sup> Meeting in its meeting held on 9.12.2004 at 11.00 AM and the guidelines issued by the Government in the Department of School & Mass Education, Orissa, Bhubaneswar vide Resolution No. 30720-SME, dt. 23.9.2996. No objection <sup>certificate</sup> is granted in favour of **D.A.V. Public School, Jharsuguda**

to open an un-aided High school upto Class-X which is to be affiliated to the CBSE/ICSE subject to the following terms and conditions:

1. The no objection certificate now issued shall be subject to the terms and condition as prescribed in the G.O. No. 30720-SME, dt. 29.9.1996 read with G.O. No. 10011-SME, dt. 11.6.2004.
2. The school shall be open for inspection by the Inspection Committee.
3. No financial assistance and G.I.A. will be claimed by the Institution from the Government at any point of time for meeting the salary cost and its component towards teaching and non-teaching staff appointed by the Managing Committee or for meeting any other expenses for managing the School.
4. The High Power Committee shall be competent to review the NOC granted to the Institution concerned and shall be competent to withdraw the same if any of the terms and conditions contained in the G.O. No. 30720-SME, dt. 29.9.1996 read with G.O. No. 10011-SME, dt. 11.6.2004, is/are violated at any time.
5. The managing committee shall be constituted in accordance with the Sec-7 of the Orissa Education Act, 1969.

Grant of N.O.C. is also subject to the fulfillment of the following requirements:

1. Own building of the school be completed within a period of one year from the date of issue of NOC.
2. The Members of the staff of the School be paid salaries at par with the salaries of the State Government with effect from the date of issue of NOC.

The Organisation/individual which has applied for N.O.C. will submit an affidavit, within a period of one month to the effect that it/she/he will fulfil the above requirements, failing which the N.O.C. will be withdrawn.
